General Business:

- 1. Approve current agenda No additions were made.

- 1. 501C3 updates

 - c. Tools and Equipment are being purchased with the RAC money and will be available for use by members working in the back country.
- 2. Volunteer Hours Even if you are not claiming reimbursement, we need an I 9 to qualify for matching funds on the grant. (In Kind)
- 3. Trail clearing reports We plan on helping maintain the trails we cleared this year. Completed reports were sent to Monique.
- 4. No upcoming work projects are scheduled this year.
- 5. Website/Newsletter Members seem very happy with both.
- 6. Rendezvous 2025 Tentative location is Rolling Hills Casino in Corning Ca. The planning committee will meet November 11th at 11:00 AM at Players Pizza in Anderson.
- 7. Laura will send out information about the State Meeting soon.
- 8. Return of the Salmon Festival is October 21st at the Coleman Fish hatchery. We will have a BCHC booth and pass out information about our organization. A horse and mule will be available for people to touch. Members are encouraged to come and help out.

- 9. Trail Boss Report We are planning a ride on November 4th at the Prather Ranch property on Parkville Road. Price will be \$20 for members and \$30 for nonmembers.
- 10. Chain saw and hand saw classes will be conducted sometime this Fall/Spring We hope to have two classes.

New Business:

- 1. Brandy Creek Project Sam reported that moving gravel and rocks up this particular trail may not be doable due to space concerns and possibly damage to the trail.
- 2. Election Process/ Nominations Nominations for the board of directors close October 31st. The Committee for this election consists of Derith Rochlitz' Nancy Anglemyer and Rose Shuman.
- 3. Our new BLM partner is David Byers. You will probably see out in the Bend area. Be sure to say hello.
- 4. Our 2014 annual dinner is scheduled for January 20th at the Sons of Italy hall in Redding. It is a fund raiser for our BCHC Shasta Trinity unit. Sam and Theresa Burrows are heading up the committee for this one.
- 5. We would like to have a tack swap where people could buy those items of that they need or sell what they don't need. If you are interested in this, let Laura know.
- 6. We may be able to have a fish plant next year. Other upcoming events for 2024 include a proposed pack-in for youth of the Pit River tribe, our annual cleanup at Preachers Meadows, clean up at Eagle Creek trailhead, and possibly rebuilding the corrals at Hay Meadow. We may also do some work with the Ascend group out of Weaverville.
- 7. BCHA wants us to report e-bikes in the backcountry and people without horses using equestrian camp grounds. Forms for making reports are available from the BCHA web site.
